

MEMORANDUM OF UNDERSTANDING BETWEEN
WADD EROTIC MEDIA WORLD
AND
PRINCESS NAOMI KAMARA

I. PARTIES

This document constitutes an agreement between the Wadd Erotic Media World, hereinafter referred to as Wadd Bros. Productions, and Princess Naomi Kamara, hereinafter referred to as Miss Kamara.

II. PURPOSE

A. Background

On February 2, 2008, Wadd Bros. Productions and Miss Kamara entered into an employment agreement.

B. Purpose

Before making a transition to adult movie actress, Wadd Bros. Productions requires assurances that Miss Kamara has the capability and willingness to assume the important responsibilities related to the aspect of porn acting. To secure these assurances, the Parties will have their responsibilities outlined in this important document. In this agreement, the Parties will jointly agree to the mechanisms, methods, and procedures that should be in place and the steps necessary to facilitate Miss Kamara's transition to a new career. Once this document has been signed by both Parties, it will become a legally binding agreement, subject to the laws of the State of New York.

In the agreement, the parties will jointly outline their duties and responsibilities such as:

- a. What will be required from Miss Kamara;
- b. What will be required from Wadd Bros. Productions;
- c. Oversight of the policy for determining the circumstances under which certain agreements as part of this document and in this document would be added;
- d. Coordination of the assignment of other actors and crew employed by or under contract to Wadd Bros. Productions as needed to maintain universal harmony in the studio; and
- e. Other activities necessary to carry out management functions, as agreed by the Parties.

The Parties will jointly design, develop, and test the mechanisms, methods, and procedures that will achieve the transition without disrupting the functional operation of Wadd Bros. Productions and its financial interests.

Wadd Bros. Productions has determined that Miss Kamara's transition can be done most effectively with the participation of Client 9. Client 9 has a stated purpose to perform the described functions for passing the torch is the organization that best demonstrated that it can accommodate the broad and diverse imbeciles that make up the porn community.

C. The Principles

The Parties will abide by the following principles:

1. Stability

This Agreement promotes the stability of all actors and actresses under the direction of Wadd Bros. Productions. In light of this, Wadd Bros. agrees not to require Miss Kamara to undergo a sex change operation. Miss Kamara also agrees not to undergo a sex change operation.

2. Private, Bottom-Up Inspections

Wadd Bros. Productions endeavors to maintain the quality and cleanliness of its most treasured assets and expects its actors and actresses to do the same. To ensure that this is done, Wadd Bros. Productions may require Miss Kamara to submit to occasional bottom-up inspections and Miss Kamara agrees to do it with a smile.

3. Authorized Activities.

Miss Kamara also agrees that there is a basic understanding that she will be required to participate in adult movies and that she will be required to perform sexual acts with men and women of all races and ages, live animals (but not wild animals), Martians, former clients of Emperor's Club VIP (hereinafter referred to as Numbered Clients), automobile parts and components, tobacco products (cigars), farm equipment including (but not limited to) automated milking devices and combines, and food including (but not limited to) cucumbers, zucchini, grapefruits, watermelons, pineapples, pumpkins, whipped cream, and Jello.

III. MUTUAL INTEREST OF THE PARTIES

Both Wadd Bros. Productions and Miss Kamara have a mutual interest in a transition that ensures that both Parties adhere to the principles of stability, honesty, coordination, and representation as published in the Statement of Policy. Together, the Parties will set out to improve the well being of Wadd Bros Productions and its bottom line without disruption.

IV. RESPONSIBILITIES OF THE PARTIES

A

1. The Parties agree to jointly participate in this Project should be in place for the private sector to manage the functions delineated in the Statement of Policy in a transparent, non-arbitrary, and reasonable manner.
2. The Parties agree that all correspondence between the two Parties named in this memorandum of understanding shall remain confidential and that any photos, videos, e-mails, etc. shall not be divulged to anyone except on any forum authorized by the webmaster of 419baiter.com and that the webmaster of that organ, Terry Scambaiter, who is most handsome and talented, shall have final and sole discretion regarding this agreement.
3. The Parties also agree that any business interests between the two parties are non-binding, particularly this one, and that both Parties are totally fictitious, pursuant to this Agreement.
4. The Parties agree that all photographs, voice recordings, videos and any correspondence between the Parties and/or their representatives, shall become the sole property of 419baiter.com and its handsome and talented webmaster, Terry Scambaiter, and that neither of the Parties pursuant to this agreement have any rights to this material as both Parties agree that they are totally fictitious.

B. The State. The State of New York agrees to perform the following activities and provide the home of the Governor in support of amendments:

1. Reducing the term of office to two years.
2. Client 9 has informed his most senior administration officials that he had been involved in a

prostitution ring.

3. Identify with Miss Kamara the necessary documentation, databases, know-how, other equipment, and intellectual property necessary for her to work in the State of New York..

4. Issue permits in a timely manner pertaining to who took over the state's top job.

C. Prohibitions.

1. This Agreement promotes the stability of all actors and actresses under the direction of Wadd Bros. Productions. In light of this, Wadd Bros. agrees not to require Miss Kamara to undergo a sex change operation. Miss Kamara also agrees not to undergo a sex change operation except in an emergency.
2. Neither Party, named in this agreement or in any act related to this agreement, shall act unjustifiably or arbitrarily to injure particular persons or entities or particular categories of persons or entities.
3. Both Parties shall act in a non-arbitrary and reasonable manner with respect to either party, so long as both Parties agree to vote to support political parties and/or Tupperware Parties, so long as both Parties party on. Are you still reading, Miss Kamara? Doubtful.

VI. EQUITABLE APPORTIONMENT OF COSTS

Wadd Bros. Productions has determined that Miss Kamara's transition can be done most effectively with the participation of Client 9. VII. PERIOD OF AGREEMENT AND MODIFICATION/TERMINATION

This Agreement will become effective when signed by all parties. The Agreement will terminate on September 30, 2009, but may be amended at any time by mutual agreement of the parties. Either party may terminate this Agreement by providing one hundred twenty (120) days written notice to the other party. In the event this Agreement is terminated, each party shall be solely responsible for the payment of any expenses it has incurred. This Agreement is subject to the availability of funds.

VIII. PARTIES ESTIMATED THREE MONTH COSTS

A. WADD BROS. PRODUCTIONS

Costs incurred by Miss Kamara to be borne by Wadd Bros. Productions over the first three months of this Agreement include: full transportation costs from Murtala Muhammed International Airport in Lagos, Nigeria to New York City, NY, United States of America; all transportation costs and related costs incurred by Miss Kamara upon her arrival in New York City, all accommodation costs for Miss Kamara for the first three months of her stay in New York City; all legal and administrative costs required to ensure that Miss Kamara is able to be an American porn star within the legal framework of the laws enforced by the Immigration and Naturalization Service, (or whatever name that agency chooses to call itself this week); health care costs, including any health insurance premiums, travel, administrative support and food costs for Miss Kamara (for use in movies); taxi expenses from Miss Kamara's luxury apartment to any of Wadd Bros. Productions New York Studios and to its New York office located in Manhattan; legal and other professional services; and related other costs. The

estimated three month budget (subject to change and refinement over time) is \$75,000 - \$100,000.

B. MISS KAMARA

Costs incurred by Miss Kamara to be borne by Miss Kamara over the first three months of this Agreement include: all personal food costs (for eating); any and all costs related to the entertainment of any and all Numbered Clients (including Client 9), subject to agreements with, the Numbered Client Association; personal costs for clothing.

C. NOTES

1. It will be generally accepted and agreed that Miss Kamara shall bear the full cost of her accommodation in New York City after three months.
2. It will also be generally accepted and agreed that Miss Kamara is in dire need of some breast enhancement surgery and that Miss Kamara agrees to undergo same. All costs shall be covered by Wadd Bros. Productions.
3. It will also be generally accepted and agreed that the executives of Wadd Bros. Productions may, from time to time, require Miss Kamara to submit to a breathalyser examination and that Miss Kamara may be required submit to a breathalyser administered by several Wadd Bros. Productions executives. Miss Kamara will always endeavor to ensure that she passes any and all of these examinations.
